**PROCUREMENT OF SUBSCRIPTION OF OFFICIAL
GAZETTE: OFFICIAL GAZETTE: VOLUME 121, NOS. 1-52
(JANUARY TO DECEMBER 2025)**

Whereas, on November 18, 2025, the Administrative Division issued the 1st Indorsement relative to the **Procurement of Subscription of Official Gazette: Official Gazette: Volume 121, Nos. 1-52 (January to December 2025)**;¹

Whereas, attached to the said Indorsement is the corresponding **Purchase Request No. 025-10-163** dated October 23, 2025² amounting to **Seven Thousand Eight Hundred Pesos (P7,800.00)**, and to be purchased directly from the **National Printing Office**;

Whereas, attached to such Indorsement are the following: (a) Certification (undated) from Chief Librarian Maria Lyn D. Madeja;³ and (b) Letter dated October 16, 2025 from the National Printing Office,⁴ both stating that the Official Gazette is only available through the National Printing Office, a government agency mandated to print and bind government publications and public documents such as the Official Gazette.

Whereas, under Section 35 of the 2025 Implementing Rules and Regulations (IRR) of R.A. No. 12009, "Negotiated Procurement" method may be resorted to in any of the following conditions:

Negotiated Procurement is a mode of procurement of Goods, Infrastructure Projects, and Consulting services, whereby the Procuring Entity directly negotiates a contract with a technically, legally, and financially capable supplier, contractor or consultant.

Negotiated Procurement shall be allowed only in the following instances:

35.5. Agency-to-Agency. Procurement of Goods, Infrastructure Projects, and Consulting Services from another agency of the government which has the mandate and absorptive capacity to undertake the project, subject to the following conditions:

- a) The Servicing Agency has certified that it has the mandate and absorptive capacity to undertake the project, and the Procuring Entity has validated the same;
- b) The Servicing Agency owns or has access to the necessary tools and equipment required for the project;

Whereas, under Section 6 of Executive Order No. 285 dated July 25, 1987 as amended by Executive Order No. 378 dated October 25, 2004, the National Printing Office has printing jurisdiction over the printing of the public document, the Official Gazette.

NOW, THEREFORE, be it resolved, as it is hereby resolved by the BAC to recommend the **Procurement of Subscription of Official Gazette: Official Gazette: Volume 121, Nos. 1-52 (January to December 2025)**, amounting to **Seven Thousand Eight Hundred Pesos (P7,800.00)**, from the **National Printing Office**, through Negotiated Procurement (Agency-to-Agency).
